

Computer Protection Agreement 2022-2023 (Grades 4-12)

The Deuel School District recognizes that with the implementation of the 1:1 computer initiative there is a need to protect the investment by both the District and the Student/Parent. The following outlines the various areas of protection: yearly licensing fee, standard warranty, accidental damage, loss/stolen and intentional damage.

STANDARD WARRANTY: The Chromebook has a one year standard warranty which warrants the computer from defects in materials and workmanship. This limited warranty covers repairs and replacement parts caused by normal use. It **does not** cover accidental or intentional damage. The students will be responsible for any repairs that would fall outside the "Standard Warranty".

ACCIDENTAL DAMAGE PROTECTION: There is **NO** Accidental Damage or Loss Protection

ACCIDENTAL and INTENTIONAL DAMAGE: Students/Parents are responsible for payment of accidental or intentional damages outlined below. Standard Warranty protection **DOES NOT** cover accidental or intentional damage of the computers.

Should your son or daughter incur accidental, lost/stolen or intentional damage to their school issued computer during the school year, the cost to repair/replace that unit will be handled as follows:

Computer Damage Charges:

Intentional Damage: 100% the responsibility of the student/parent which be assessed that the time.

Lost or Stolen: Replacement Value

Accidental damage will be billed as follows (Any Model of Chromebook): Damages are Cumulative but will not exceed \$150.

Keyboard Only	\$20 (price subject to change)
Damaged LCD	\$40 (price subject to change)
LCD Back Cover	\$25 (price subject to change)

Bottom Case	\$20 (price subject to change)
DC Jack	\$10 (price subject to change)
Hinges	\$10 (price subject to change)
Hinge Cover	\$10 (price subject to change)
Broken Keys	\$5 (that can be replaced) (price subject to change)
Other Damages	To be assessed and be billed by cost of parts not to exceed \$100
Power Adapter (charger)	\$20 (Separate charge and not included in cumulative bill)
Bag or Protective Case	\$25 (Separate charge and not included in cumulative bill)

Other:

If the computer is damaged and the student/parent will have the following options:

1. If the unit is worth repairing (determined by Deuel School), have the computer fixed and pay all damages associated with the repair as outlined above; or in the case it is not worth repairing...
2. Choose to buy the computer for the replacement value, please note that you will receive the computer "As Is" and the computer will not be repaired. You will assume the responsibility of fixing the unit if you so choose. The student will be issued a substitute computer.
